- The Belmont Sports and Recreation Club is licensed premises. No BYO alcohol.
- No person shall commit any act of gross negligence or wilful damage of club property.
- No person shall threaten or engage in abuse or violence against another person whilst on club premises.
- No person shall engage in any form of harassment, bullying or discrimination of any other person or group of persons.
- No person shall take any action that impacts the health and safety of another person.
- No person shall fail to follow a direction from a committee member or a properly constituted person of the Club.
- No members shall fail to treat all other members, guests and committee members with courtesy.
- No person shall engage in misrepresentation for personal gain.
- All members of the Club must respect the legal rights and privileges of all other persons whilst on the premises.
- No smoking/vaping in the pit areas, toilets, race control area, drivers stand and out on the track.
